## PREAMBLE

The purpose of this privacy policy is to inform users of the site:

- How their personal data is collected. Personal data is any information that can be used to identify a user. This may include, but is not limited to: first and last names, age, postal or e-mail address, location or IP address;
- On the rights they have concerning this data;
- Who is responsible for processing the personal data collected and processed?
- the recipients of this personal data;
- the site's Cookie Policy.

## PRINCIPLES GOVERNING THE COLLECTION AND PROCESSING OF PERSONAL DATA

Personal data is:

- Processed lawfully, fairly, and transparently with regard to the data subject;
- Collected for specific, explicit, and legitimate purposes, and not further processed in a way incompatible with these purposes;
- Adequate, relevant, and limited to what is necessary for the purposes for which they are processed;
- accurate and, where necessary, kept up to date. All reasonable steps must be taken to ensure that personal data that is inaccurate, having regard to the purposes for which it is processed, is erased or rectified without delay;

- Kept in a form that permits identification of data subjects for no longer than is necessary for the purposes for which they are processed;
- Processed in such a way as to guarantee appropriate security of the data collected, including protection against unauthorized or unlawful processing and against accidental loss, destruction, or damage, using appropriate technical or organizational measures.

## **PERSONAL DATA COLLECTED AND PROCESSED WHEN BROWSING THE SITE**

### **Data collected**

The personal data collected in the course of our business is as follows:

- your name and contact details (e.g. name, address, telephone number, or e-mail address), as well as other basic information;
- technical information (e.g. your IP address, your operating system, your browser, the date and time of your visit, etc.);
- information on your behavior on jc2033.world (e.g. information on your interaction with the site, your requests, or the pages you visit);
- information relating to documents and communications we send you electronically (e.g. your use of e-mail for marketing purposes);
- any other information about you that may be useful for the performance of our services and the processing of your requests (e.g. in connection with a seminar registration).

This data is collected and processed for the following purpose(s):

- managing event registrations;
- processing your contact requests;
- sending of e-mailing (newsletter);
- legal obligations of the host (server logs).

### **Data collection method**

When you use our site, the following data is automatically collected:

- the technical information mentioned above

Other personal data is collected when you carry out the following operations on the platform:

- Event registration;
- Contact via the form on the contact page;
- Newsletter subscription.

This data is kept by the data controller for as long as is necessary for the purposes for which it was collected.

JC2033 may retain certain personal data beyond the above-mentioned periods to meet its legal or regulatory obligations.

## **Cookies**

A cookie is a small text file consisting of letters and numbers that we store on your browser or computer's hard drive. This helps us to provide you with a better experience when using jc2033.world.

We use "session" cookies, which are strictly necessary. These are temporary cookies that contain the site identifier and a session number. These cookies are used for site navigation and are automatically deleted when you close your browser at the end of your session.

In general, you can block cookies by activating the setting in your browser that allows you to refuse all or some cookies. However, if you use your browser settings to block all cookies (including strictly necessary cookies), you may not be able to access all or part of our website.

jc2033.world uses external/third-party web services, some of which may also use cookies. This Privacy Policy does not include third-party websites, which will be subject to their own privacy and cookie policies. We do not have access to or control over cookies or other features used by these websites. Please contact them directly for further information on their privacy practices.

## **Sharing your personal data**

- Right, not to be the subject of a decision based exclusively on an automated process;

- Right to contact the competent supervisory authority, in Switzerland the Federal Data Protection and Information Commissioner (FDPIC).

For the data controller to process your request, you may be required to provide certain information, such as your first and last name, e-mail address and account, personal space, or subscriber number.

You may withdraw your consent to direct marketing methods and ask us to remove your information entirely from our database for marketing purposes by using the link in the relevant newsletter communication.
