- Prayer at the Hermitage of Gethsemane
- Meditation on the Stations of the Cross
- Basilica of the Resurrection and Holy Sepulchre

Why?

Almost 2000 years ago, two disciples, walking between Jerusalem and Emmaus, had an encounter that changed them forever. To prepare for the celebration of the 2000th anniversary of the resurrection of Christ, JC2033 invites you to walk along this path which is so important for all Christians!

- This walk will be preceded by two days in Jerusalem, in the traditional place of the events of Jesus' death and resurrection.
- We want to walk with Christians from Jerusalem and meet the communities on the roads to Emmaus, visiting the various places identified with Emmaus: Motza, Abu Gosh, and Nicopolis.
- This walk will be punctuated by times of sharing and prayer.
- We also hope that these days will be rich in encounters between Christians from different churches and countries.
- Living the Easter season in Jerusalem and on the road to Emmaus is a special experience that centers us on the heart of the Christian faith. This walk will also be a time for spiritual renewal.

PACKAGE PRICE WITHOUT FLIGHTS

- **GBP 1'295.00** if 30 + participants (price for a double room).
- **GBP 1'425.00** if 20-29 participants (price for a double room).

The number of participants is limited to 30. Registrations will be taken on a first-come, first-served basis. The number of single rooms is limited to 7.

THE PRICE INCLUDES

- 7 nights' accommodation in a B&B (basic comfort).
- Double room with WC/shower
- Breakfast and evening meal (including soft drinks) each day:
 - 6 breakfasts in the guest house
 - 5 evening meals in the guest house
 - 1 evening meal out
- Travel by coach with a private driver.
- Local English-speaking guide.
- All entrance fees to sites mentioned (details of tickets for visits).
- Tips.

THE PRICE DOES NOT INCLUDE

- Flights are the responsibility of each participant.
- Transportation to and from the airport.
- Lunch (picnics if reserved beforehand with Salesian guesthouse).
- Additional drinks during meals
- Single room supplement: GBP 180.00 for the whole week.
- Travel insurance, covering cancellation costs and assistance/repatriation.
- Visa fees, if applicable.

If the number of participants is less than 20, the trip will be canceled (participants will be notified by March 2nd, 2026). In this case, the deposit will be refunded in full. As the final price of the trip depends on the number of participants, the final amount will be communicated to you on March 2nd, 2026.

WALKS ON THE ROAD TO EMMAUS

The three walks (10km, 14km, and 5km) are not very difficult. There is little difference in altitude. However, walking shoes (or good trainers) are mandatory and sticks are recommended.

You will need to be in good physical condition.

COVID-19 MEASURES AND INSURANCE

Currently, no Covid measures are required to enter Israel. Subject to change.
Travel insurance covering cancellation costs, accidents and assistance/repatriation is compulsory. Please contact your insurance company or the TCS (ETI booklet) or another organization.

FORMALITIES

Passport required, valid at least 6 months beyond travel date. No visa is required for UK, Swiss, and Philippine passport holders.

CANCELLATION POLICY

In the event of cancellation of a definitive booking by the participant, the following charges will be payable by the participant (or by his cancellation insurance):

- + 90 days before departure: GBP 350 per person.
- 89 to 41 days: 60% of the price of the trip.
- 40 to 0 days: 100% of the price of the trip.

TRAVEL LIABILITY

On receipt of your registration, we will send you an invoice for the deposit. This will be accompanied by a Liability Waiver form. The signature of this document is required by the local tourist agency we work with, and is an integral part of the travel contract.
